**Eligible Investment Categories** 

Local governments can invest their annual CWF allocations in 21 unique capital and capacity building project categories, described in more detail on the following pages.

Within these categories, local governments can acquire, plan, design, build, or renovate, or extend their life span of tangible capital assets<sup>1</sup>.

Project funding can be used for planning purposes, including detail design documents and feasibility studies, through the appropriate funding category. The studies must be tied to an identified capital project, but do not need to lead to the construction of capital infrastructure projects to be eligible.

The following projects examples are ineligible uses of Community Works funding:

City halls, public works buildings and other administrative buildings
Child care centres
Social housing
Seniors care facilities and housing
Health care related infrastructure
Small equipment purchases as stand-alone projects

<sup>&</sup>lt;sup>1</sup> Tangible capital assets are non-financial assets having physical substance that are acquired, constructed or developed and: (i) are held for use in the production or supply of goods and services; (ii) have useful lives extending beyond an accounting period and are intended to be used on a continuing basis; and (iii) are not intended for sale in the ordinary course of operations.
